JOINTLY DEVELOPED

Garrison-Pilcher Elementary will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

A careful review process including parents, school, and district leaders is completed each summer to ensure that required plans are written in an understandable and uniform format and to the extent practicable, provided in a language the parents can understand by involving parents in the editing process.*
 - *Meetings will be offered at various times, such as morning and afternoon sessions whenever practical. Meetings will be provided in formats aligned to meet needs of our parents. Home visits often provide a chance to review meeting details, develop parent capacity, and solicit feedback. Parents may request alternative meeting formats by contacting the school parent involvement coordinator directly.*
 - *School-based parent involvement coordinators are able to provide assistance with transportation or child care if such issues present a barrier to participation in school events. These services may be scheduled by contacting the parent involvement coordinator directly.*
 - *A Community Outreach Team has been established to go out into the local/surrounding communities and supply parents with materials to help their child with reading and math. The materials will include, but are not limited to: flash cards, pencils, crayons, composition notebooks, books, and more. We will work on building a positive relationship with parents while making sure all parents have equal opportunities to get proper help with making sure their child is successful in school. The team will consist of administration, counselor, parent involvement coordinator, first grade teachers, and second grade teachers. We will meet at a local business (e.g., library, community center, etc).*
