Dr. Kornegay called the board's attention to a letter from the United States Department of Justice to Governor Deal notifying him that the Department of Juvenile Justice was filing a lawsuit against Georgia regarding the Georgia Network for Educational and Therapeutic Support (GNETS) program. It alleges that students served by GNETS are housed in buildings that are not equivalent to their non-disabled peers and that they do not have access to things offered at regular schools such as gymnasiums, libraries, and curricular activities and they are segregated from non-disabled peers. Dr. Kornegay said a team of contractors and architects were sent to visit every GNETS site in Georgia and they recommended that nine centers be closed and eight of those were closed prior to school starting in late July. He said he is not expecting any sites that Thomas County is

fiscal agent for to be closed but is expecting mandatory upgrades. Dr. Kornegay said he would keep the board updated with the developments of the lawsuit.

- D. Facilities planning report
 - 1. Board of Education Campus

Dr. Kornegay said the following improvements would be made to the Board of Education campus: storm drainage control, gutter damage along Pinetree Blvd., cafeteria, traffic flow and appearance to the front of the campus.

- 2. Baseball complex
 - Dr. Kornegay said plans have been in the works for several years to do something for baseball similar to what was done for softball. He showed a drawing for a proposed new baseball building which would include dugouts, locker room, restrooms and a concession area and said that coaches have had significant input in the design.
- 3. Bishop Hall Agriculture-Science Building
 Dr. Kornegay showed the board a drawing for Bishop Hall's Agriculture-Science
 building. He said there would be two classrooms, student restrooms, an office for
 two teachers, a nice agriculture shop, a little covered patio outback, and a science
 lab in the building. He said a grant for equipment has been applied for and should
 be received since it is a new building.
- 4. Football Stadium

Dr. Kornegay reported on plans to modernize the stadium. He said input had been received from the Booster Club, coaches, high school administrative staff and the architect. Some of the improvements included a new entrance area, a new ticket booth, nice gates, brick columns, closing in the bottom side of the stadium with metal, enhanced lighting at the back of the stadium and repairs to the stands.

- E. Pre-Kindergarten Programs Policy (IDDK) first reading
 - Dr. Kornegay said the Department of Early Care and Learning is requiring the admission process for Pre-K to be put in board policy. He said the procedure that has been followed for years is what has been put in the policy. Priority for the Pre-K program is given to Thomas County residents first and they also get first priority on the waiting list, if there is one.
