- A. Presentation of donation from Envision Credit Union for REACH Scholarship Mrs. Lee Bryant Dr. Kornegay explained that REACH Scholarships are funded through a partnership with local sponsors and the state of Georgia for aspiring students with a financial need. Dr. Kornegay introduced Mrs. Lee Bryant from Envision Credit Union, who presented the first REACH donation in the amount of \$1,500 to the school system.

- G. Report on diesel spill near Garrison-Pilcher Chad Gunter, Advanced Environmental Technologies
  - Mr. Chad Gunter from Advanced Environmental Technologies reported on the diesel spill

recently near Garrison-Pilcher School and said he had a successful report for the board. He explained that a gentleman had driven 45 miles from a terminal with 3000 gallons of diesel fuel and while at the Murphy Station near the school, he dumped 2000-3000 gallons of diesel fuel into a creek. He said it made its way to the creek behind the school and up to the north bypass but it has been cleaned and the person that dumped the diesel fuel has been arrested and is in jail. Mr. Gunter said that after taking the last sample, it showed that there is no additional diesel range organics in the creek and there were no fumes in the classroom air conditioners that were tested. He recommended taking another sample in three to six months as a precaution.

Mrs. Melanie Chavaux led the grant writing team and she shared an overview of the grant. She said the L4 GA grant is Literacy for Living, Learning and Leading and much of the work with this grant would be a continuation of the work that is being done with the 2.7 million dollar Striving Readers grant.
